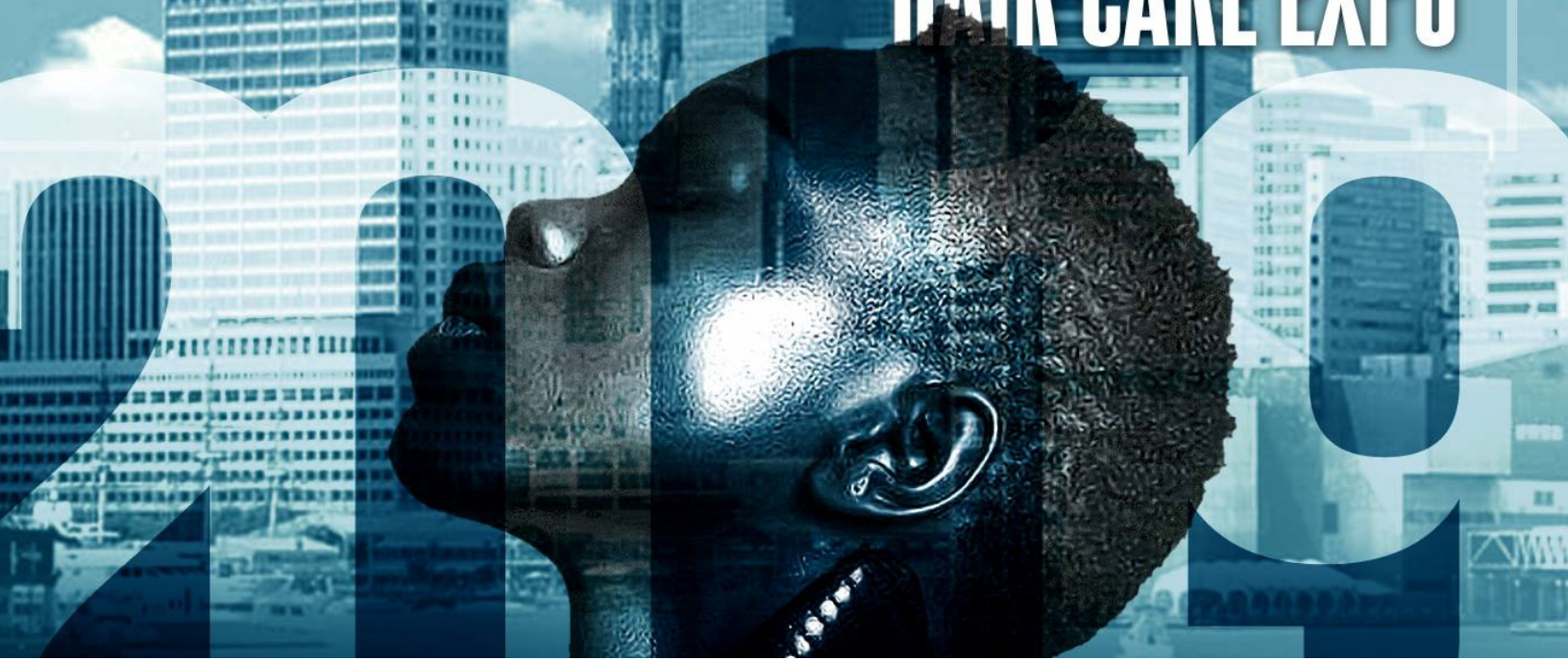

VENDOR BOOTH CONDITIONS

1. Booths and tables include a minimum of two people per booth or table; maximum of 6. Additional guests must pay 1/2 show admission at vendor check-in. Payments for all items selected must be received in full with this agreement or it will not be processed.
2. Tables are non-transferable to other people or other shows and may only be used by the Vendor specified in this contract. All displays must be complementary to the show and must be confined within the booth space purchased.
3. No loud speakers or amplifiers or loud music is permitted.
4. Vendors must check-in and set up assigned table at least 1.5 hours prior to show opening and the table must be set up prior to show opening. Tables must be manned at all times during the show. No early breakdowns are allowed and vendors are expected to remove all materials at the end of the show. Please contain all trash.
5. Vendor assumes full liability and risk and holds Natural Hair Care Expo (NHCE), Malaika Tamu-Cooper, Dreadz N' Headz, and any event/show affiliates harmless against and from any loss or damage as a result of this show, including damage to personal property or guest injury.
6. Vendor agrees to obtain insurance at his own expense to protect vendor's property against fire, theft, accident or any other cause.
